Whereas the Municipal Council of the Town of Sundre (the "Town") desires to initiate the dispute resolution process under its Inter-Municipal Development Plan with Mountain View County ("the County") which plan was adopted by the Town on September 19, 2007 as Bylaw No. 14/07 (the "IMDP");

And Whereas the Municipal Council of the Town has deemed that:

1. it has a "lack of agreement" with the County on:
  - a. proposed statutory plan Bylaw No. 09/12, "A Bylaw to adopt the Mountain View County Municipal Development Plan", which Bylaw was given first reading by Mountain View County Council on May 16, 2012 (the "MDP") and
  - b. interpretation of the Inter-municipal Development Plan (IMDP);
2. the MDP affects the inter-municipal plan area established under the IMDP; and
3. the MDP is inconsistent with the policies of the IMDP and/or is detrimental to the Town's planning interests as a municipality;

NOW THEREFORE BE IT RESOLVED THAT:

The Town sends the attached dispute commencement letter, over the signature of the Mayor, to the County to commence and initiate the dispute resolution process under P.6 (Dispute Resolution) of the IMDP to resolve the disagreements of the Town with the proposed MDP of the County.
