### TO AMEND LAND USE BY-LAW NO. 705

The Town's Land Use Bylaw 705 is currently under review, the purpose of this proposed amendment is to address Accessory Buildings, Day Cares, Home Occupations and Sea Cans to provide a clearer definition and greater understanding of each of these Uses in the Land Use Districts.

A Public Hearing prior to second and third readings of the proposed By-Law No. 07.16, will be held on Monday, January 16, 2017 at 6:00 P.M. in Council Chambers during the regular Council meeting.

## CHANGES TO UTILITY BILL RATES

**Changes to TOWN OF SUNDRE UTILITY BILL RATES effective January 1st, 2017.**  
(Beginning on the February 2017 billing for January services)

**Monthly Flat Water Rate** changes from \$19.50 to \$20.50

**Water Consumption Rate:** No change, remains at \$2.25/m<sup>3</sup>

**Monthly Flat Wastewater Rate** changes from \$19.50 to \$20.50

**Wastewater Rate:** No change, remains at \$1.35/m<sup>3</sup>

**Monthly Flat Gas Rate** changes from \$25.50 to \$26.00

**Gas Distribution Rate:** No change, remains at \$1.45 per Gigajoule

**Monthly Flat Garbage Rate:** No change, remains at \$25.65

**Gas System Improvement Charge:** No change, remains at \$0.21/GJ

- Funding future projects to replace aging gas pipeline in our distribution system.

**Storm Water Fee** changes from \$5.15/month to \$5.25/month

- Funding storm water infrastructure projects that ensure drainage to manage flooding issues.
