### 2018 UTILITY RATES

Town Council has passed the 2018 Rates and Fees By-law setting a **zero increase** in Utility Rates from 2017.

Town of Sundre Utility Bills will reflect the Alberta Government's Carbon Levy Rate increase from \$1.01/Gigajoule to \$1.517/Gigajoule on natural gas consumption.

The Town of Sundre is required to collect this levy and pass it on to the Province.

### Council Remuneration Review Committee

**JURISDICTION:** *Municipal Government Act*

### MANDATE:

The Committee will function as an Ad-Hoc Committee of Council. The role of the Committee is to research, develop, and present a report with recommendations concerning Council Remuneration for the Term 2018-2021.

The Committee will present a report to Town of Sundre Administration.

Areas to be addressed include:

- Salary for Mayor and Councillors, including methodology, comparators and frequency
- Per Diem – amount and application
- Benefits
- Expenses
- Mileage
- Any other matter directly related to Council remuneration

### COMPOSITION:

Up to 5 members of the Public as appointed by Council and the Town of Sundre, Chief Administrative Officer (non-voting member).

### TERM:

The Committee's Mandate will expire once Town of Sundre Council has approved the rate of remuneration for the 2018 – 2021 Council Term.

### MEETING TIME:

Meetings will be held at the call of the Chair, as required.

### REMUNERATION:

Volunteer position
