REPORT TO COUNCIL

COUNCIL DATE SUBJECT REPORT WRITER January 9, 2023 Bylaw Review Project-History and Status Chief Administrative Officer

BACKGROUND/PROPOSAL:

Administration began a Bylaw Review Project in 2018, which consisted of a full and comprehensive review of all Town Bylaws, and the creation of a formal file management system for all Town of Sundre Bylaws, dating back to the first Bylaw adopted by Sundre Town Council.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

Administration has undertaken a review of all Bylaws of the Town of Sundre, dating back to Thursday, February 23, 1950, which is the date of the first Bylaw adopted by the Sundre Town Council.

Following were the steps taken to initiate the process:

- The first step in the process was to identify and list each Bylaw, by number and date.
- The Bylaws were then scanned and stored on the server by year of adoption.
- Once all Bylaws were listed, each Bylaw was broken down into a category, such as Debenture Bylaw, Land Use Bylaw, Animal Control Bylaw, etc.
- The Bylaws were then separated into four distinctive groups:
 - Bylaws for archives;
 - Land Use Bylaws;
 - o Bylaws Requiring Repeal; and
 - o Bylaws Requiring Updates.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

On February 26, 2018, the CAO presented a report and a list of Bylaws for archiving. The Bylaws consisted of Road Closure Bylaws, Mill Rate Bylaws, (some are listed as Assessment or Tax Bylaws), Debenture or Borrowing Bylaws, Staff Appointment Bylaws, and miscellaneous Bylaws that should never be repealed, but are no longer current. For example, each year Council will

adopt a Mill Rate Bylaw, with the newly adopted Bylaw superseding the previous year's Bylaw. The previous year's Bylaw will become a record, as it is no longer applicable in the current year. The Bylaws within this category must never be repealed, as they are permanent records of the Town.

The next step was to archive Land Use Bylaws, separately from the previously archived Bylaws. On March 5, 2018, the CAO presented a list of all Land Use Bylaws that will be archived separately from the Road Closure Bylaws, Mill Rate Bylaws, Debenture or Borrowing Bylaws, Staff Appointment Bylaws, and miscellaneous Bylaws. The Land Use Bylaw is a living documents and the Bylaw Amendments will form part of the Town's permanent record. This category also includes Bylaws delegating Planning and Development Authorities.

On March 12, 2018, the CAO presented an index and record of Bylaws that had been rescinded/repealed through Motion of Council,

On March 19, 2018, the CAO presented a list of additional Bylaws, including Land Use Bylaws, to be archived.

On April 9, 2018, the CAO presented a report describing the process to follow for Bylaws that have been defeated or have never received final reading. Under Section 188 of the Municipal Government Act, and Section 27.11 of the Town of Sundre Procedural Bylaw, if a Bylaw:

- (a) does not receive third reading within two years from the date of first reading, the previous readings are deemed to have been rescinded, and
- (b) is defeated on second or third reading the previous readings are deemed to have been rescinded.

The Report included a list of Bylaws that have been Defeated, a list of Bylaws that have not had any readings, and a list of Bylaw Numbers where Bylaws have not been assigned or drafted.

On April 16, 2018, the CAO presented a Bylaw to rescind Bylaws that are outdated, or extraneous and no longer relevant to the Town of Sundre. On May 7, 2018, the Bylaw was updated to reflect current provisions under the *Municipal Government Act*. Under these provisions, a Council may by Bylaw revise any of it's Bylaws or any one or more provisions of them in accordance with s. 63, provide that the Bylaw contains the words "Revised Bylaw" and that the Chief Administrative Officer has certified in writing that the proposed revisions were prepared in accordance with this section. Section 65 of the *Municipal Government Act* states that a Bylaw made in accordance with all the other requirements of the Act respecting the passing and approval of those bylaws, including any requirements for advertising and public hearings

Each archived Bylaw will be listed and stored on the server and in hard copy in a binder. The contents/records page will be updated on a regular basis to ensure that our record keeping is

accurate and up to date. Each time a new Bylaw in the archive category is complete, it will be transferred to the binder and recorded.

Each archived Land Use Bylaw will be listed and stored on the server and in hard copy in a binder. The contents/records page will be updated on a regular basis to ensure that our record keeping is accurate and up to date. Each time a new Bylaw in the Land Use Bylaw category is complete, the "Master" Land Use Bylaw will be updated, and the amending Bylaw will be transferred to the binder and recorded.

The Defeated Bylaws will be listed and stored on the server and in hard copy in a binder. The contents/records page will be updated on a regular basis to ensure that our record keeping is accurate and up to date. Bylaws will be archived on an ongoing basis, and will be transferred to the appropriate Bylaw binder and recorded.

Staff will keep a master index of all Bylaws, which will contain information on the category of each Bylaw, where the Bylaw is stored, on both server and binder, and the status of the Bylaw, as shown on the attached Bylaw list.

The project has been substantially completed, however, it did stall as other matters trumped this project on the priority list. It is the intent of staff to have this project completed during this term of Council.
