REPORT TO COUNCIL

SUBJECT: Temporary Off-leash Dog Park REPORT WRITER: Planning and Development

AGENDA ITEM: 4.1a BACKGROUND/PROPOSAL:

At the Regular Council meeting on June 26, 2023, council directed administration to bring information back based on the results of the Open House for the eastside campground lands and to investigate the use of land in the SW under residential development for an Off-leash Dog park.

DISCUSSION:

The public open house held on June 27th regarding the eastside campground and passive outdoor recreation area was well attended and administration received some excellent ideas regarding passive recreation uses for the area. Of the +/- 70 people in attendance, 3 people supported a dog park in this area.

Apart from the comments received at the eastside campground open house, we have received 4 requests for a dog park over the past few years; 3 from Town residents and 1 from a county resident.

Although the Developer of a residential project in the SW suggested that a portion of his lands could be used for a dog park, this area is not suitable for a dog park as future development would have the park immediately adjacent to residential properties. And further, to develop a temporary dog park would require 6th Street S.W. to be upgraded, a parking lot to be constructed, and increased costs would be incurred to fence and gate four (4) sides of the area. The developer does plan to upgrade 6th Street S.W. south of the Seniors Housing complex, but at a later phase of the residential development, date unknown at this time.

The proposed site for the temporary dog park is the TC Energy Pipeline Right-of-Way adjacent to the Town Office located at 717 Main Avenue West. We propose that parking for dog owners be located on the eastside of the Town Office parcel, with access to the park through a man gate and gated corral in the southeast corner of the dog park area (on the south of the Town's storage garage located in the rear yard of the Town Office site). Dog owners would keep their dog(s) on leash until they enter the entrance corral. An equipment gate will be provided for mowing equipment at the north end of the dog park. Currently, Community Services provides mowing of the pipeline 5 times yearly.

The recommendation of the fencing contractor is to install four (4) foot chain link fencing utilizing other existing fencing. A crossing application has been submitted to TC Energy as the fence posts will be driven in to a depth of 30" or 0.762 m. A non-disturbance style of fencing is not recommended as safety issues may occur with unfavourable weather conditions. Use of page wire was considered as it may be less expensive than chain link, however the recommendation is that it not be used as it can be unstable, would not be able to withstand Sundre's snow load and small dogs may escape through the holes in the wire.

TC Energy's preference is that the land remain in its natural state (grass) with no gravel to be added to the area. Snow clearing is not an option in winter, as the equipment to be utilized will be heavier than the Kubota lawnmower that is utilized to maintain the grass.

On July 18th, administration met with the fencing contractor to finalize the plan for the temporary dog park. Attached is a drawing indicating the fence lines (green), gates (red) and the corral (orange) as shown in Appendix 1.

Administration is recommending six signs to be installed, indicating the parking area, no access to and from the Town office parcel from the lane on the southside, identification of the park on the fence facing Main Avenue West, and a large sign for the Rules & Regulations. Examples for the signs are shown in Appendix 2.

A budget has been prepared showing the cost of fencing/gates, signs, doggie bag dispenser, bags, and garbage receptacle (Appendix 3). Please note that the total is less than previously reported, as administration is no longer recommending a non-disturbance style of fencing.

Expectations for the users of the off-leash dog park will entail that each dog owner manage their dog(s) waste, limit others to exposure of disease by ensuring that their dog(s) is fully vaccinated and if un-well keep their dog(s) at home and should take measures to mitigate the risk of aggressive behavior with positive training methods. Users should be notified that failure to keep this area free of dog waste could result in the closure of the park. Dog owners may bring water from home but should not share the water source (bottle or bowl) as this may be a source of disease transmission, therefore water will not be provided. All use of the site will be at the owner's own risk.

Further research by administration resulted in a phone conversation with the Supervisor of Parks and Facilities, Town of High River. High River has two (2) off-leash areas:

- 1. Permanent Little Bow Off-leash Park, adjacent to High River's Little Bow Campground, area established with removal of several campsites, land owned by Town of High River, full chain link fencing installed, with access gate, lots of trees, garbage cans and baggies provided, grass mowed twice yearly, garbage cans emptied weekly.
- 2. Temporary 5 acre Bishop Off-leash Park, land donated by Bishop Family (local veterinarian), adjacent to commercial district, future sale & development of land possible off-leash park will be removed, also adjacent to a school site, fencing from Canadian Tire and school utilized with "page-wire" (similar to what elk farms use) to complete off-leash area, benches, garbage cans and doggie station (baggies) installed, no trees, no water provided, dog owners are encouraged to walk with their dog(s), grass is mowed twice yearly spring & fall, no snow clearing in winter.

Issues:

- dog owners not cleaning up waste;
- risk of transmission of disease (Parvovirus alert issued Aug. 2022);
- removed water stations in both parks due to water being contaminated;
- page-wire installation required 2 x 6 boards to be installed at bottom to prevent small dogs escaping through holes in the page wire.

CONCLUSION:


Administration is confident that Council has sufficient information to make a decision to proceed with the Sundre Temporary Off-Leash Dog Park at the recommended location on the TC Energy Pipeline Right-of-Way (Plan 8910920, 51MR) adjacent to the Town Office, 717 Main Avenue West, until such time as land is available for a permanent off-leash park.

RECOMMENDED ACTION:

Administration recommends that the TC Energy pipeline right-of-way, Plan 8910920, 51MR, be used for a temporary off-leash dog park until such time as land is available for a permanent off-leash park, subject to TC Energy's crossing approval or, at Council's discretion.

TOWN OF SUNDRE: TEMPORARY OFF-LEASH DOG PARK

5 – 4' X 4'SIGNS and 1 – 4' x 8' Rules & Regulations Sign

- 1. TOWN OF SUNDRE OFF-LEASH DOG PARK (2 signs for fencing facing Main Avenue West and south boundary lane)
- 2. NO ENTRY / EXIT (2 signs for north and south side of fenced off lane dividing town office & Noblefern subdivision)
- 3. PARKING FOR OFF-LEASH DOG PARK (1 sign with an arrow pointing to east side of town office parcel)

4. RULES & REGULATIONS

- Dog owners using the off-lease dog park are using it at their own risk.
- > The Town is not responsible for injuries to owners and dogs or illnesses dogs may contract from other dogs.
- > Dogs must be at least 4-months of age to enter the park.
- Dog owners will maintain their dog(s) on a leash until the dog enters the park.
- > Remember to keep the gate(s) closed to prevent escape attempts.
- > Only one person and their dog(s) in the entrance corral at any time.
- > The Town reserves the right to eject or prohibit anyone from the dog park at any time for any reason.
- Adults must accompany children under the age of 14.
- > Leashed dogs are not permitted within the dog park.
- Dog Park hours are 7:00 a.m. to 9:00 p.m. (summer) and 8:00 a.m. to 6:00 p.m. (winter)
- > For safety reasons no one shall enter or use the dog park after dark.
- > Dogs must never be left unattended.
- All dogs must wear a current license and vaccination tags.
- Unruly or aggressive dogs are not allowed.
- > Female dogs in heat are not allowed.
- > Dog owners must clean up after their dog(s), and dispose the waste in the receptacle provided; failure to clean up will result in closure of the park.
- > Owners must stop their dog(s) from digging. Any holes created must be filled by the owner of the dog(s).
- > Smoking, alcohol or drug use is prohibited.
- Unauthorized pieces of equipment, obstacles or apparatus are not allowed in the designated dog park, this includes but is not limited to: balls, frisbees, pull-toys, pylons, slalom stakes, tubes.
- > No food or eating is allowed in the park.
- > Glass containers are not allowed in the dog park.

BACKGROUND/PROPOSAL:

The Hwy 27 Water & Wastewater upgrade project was approved in the 2023-2032 Capital Plan at a cost of \$1,806,000. The intent of the project is to repair and replace the end-of-life infrastructure under Hwy 27 and to time this underground work to coincide with the Alberta Transportation (AT) overlay project.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

The tender process was initiated and closed in July 2023. Unfortunately, as contractors are very busy this year, only one bid was received. AIC Construction was the sole bidder and has worked previously on Town projects with good results. In addition to limited availability of service providers, other significant constraints exist for the project including it being a high load corridor, a busy highway with limited options for detour, timing the completion of the project with AT, and removing the temporary round-a-bouts. Due to all these factors, the bid amount has increased significantly above estimate and the revised cost of the project is \$2.9M. Administration is attempting to access alternative sources of funding, but these are uncertain at this time and to ensure the project moves forward in a timely fashion Council would be required to commit Town funds with any outside funding received then being returned to the appropriate restricted surplus account.
