


### DogRib Fire 2001 11,000 ha















Municipal Councils have oversight over municipal libraries a per the *Library Act.* As such, the Town of Sundre Council should approve changes to the firm providing a financial review for the Sundre Municipal Library. Historically, the Sundre branch of Hamilton & Rosenthal was the approved financial reviewer for the financial reporting of the Sundre Municipal Library to the Town of Sundre Council. In late 2023, the Sundre branch of Hamilton & Rosenthal transitioned by name only to Sunstone Chartered Professional Accountants.

#### DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

The Sundre Municipal Library Board sought advice from the Public Library Service Branch of Municipal Affairs on January 22, 2025 pertaining to the name change of the accounting firm responsible for reviewing the Library's financial records. AECOM, construction consultants to Alberta Transportation & Economic Corridors (TEC) have requested on behalf of the construction contractor a relaxation to Bylaw 2023-09 Community Standards Bylaw, Part 2 Noise.

#### DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

The Community Standards Bylaw, 2023-09, Part 2 - Noise, s.2.30 states: "no person shall carry on construction of any kind that can be heard beyond the boundary of the construction site after the hour of 10:00 p.m. in the evening, and before the hour of 7:00 a.m. in the morning of any day; and further, s. 231 states: "no person shall operate any equipment, machinery, or mechanical devises or any other tool or device of a noisy nature that may disturb persons in a Residential District."

AECOM on behalf of the construction contractor is requesting that Council approve a relaxation to the bylaw, as the project may require extended work hours. Specifically, the contractor may be required to potentially work past 10:00 p.m. and start before 7:00 a.m. on certain days during concrete pours and asphalt work.


